Role Overview

A fantastic opportunity has arisen to join our team of committed class teachers and take on the role of Class 1 Teacher from September 2021.

We are looking for an experienced class teacher who possesses the ability and motivation to work with our team to provide an outstanding lower school education to our class of young, enthusiastic learners. A Steiner teacher training and/or significant experience as a Class Teacher in a Waldorf School is essential and QTS and/or experience in other educational settings, including state or independent schools, is desirable but not essential.

The hours and pay for this role are dependent on what other specialist subjects you are able to teach or responsibilities you are able to take on, outside of main lesson time.

Main responsibilities of the post:

- To teach Class 1, following the school's curriculum which is inspired by the Steiner curriculum.
 - At The Acorn School we teach combined classes and therefore, in September 2022 you will welcome the new class 1 students, who will join your existing students as a class 1 and 2.
- To carry out class teacher duties including pastoral care, planning, assessment and tracking.
- To take overall responsibility for your class, including:
 - supervising, managing and assessing the children
 - liaising with colleagues and parents
 - record keeping and report writing in accordance with statutory and school requirements
- To undertake appropriate preparation, study and training as necessary both for the effective delivery of the curriculum and to advance the school's standards, ethos and objectives.
- To work towards developing the overall quality of the teaching and learning in the Lower School.
- To attend meetings with staff and parents.
- To support the school's ethos, principles and objectives
- To be aware of the school's policies and procedures and to support their implementation and development
